The Act grants autonomy to All India Radio and to Doordarshan, both of which were previously under government control. The Act received the assent of the President of India on 12 September 1990 after being unanimously passed by Parliament.

The Prasar Bharati Amendment Act of 2011, amended provisions to ensure that all posts in Akashvani and Doordarshan, barring few exceptions, shall be deemed to have been transferred to the Prasar Bharati from April 1, 2000. The amendment act had defined the service conditions of several of the employees in some of the key areas.

[11B. Transfer of posts of Akashvani and Doordarshan to Corporation. - (1) All posts in the erstwhile Akashvani and Doordarshan other than the posts borne on the strength of the cadres referred to in sub-section (2) shall be deemed to have been transferred to the Corporation with effect from the 1st day of April, 2000.

The Prasar Bharati was established on November 23, 1997 and consists of Akashvani (All India Radio) and Doordarshan. The primary function is to provide public broadcasting services. The Act allows the central government to transfer officers and employees serving in Akashvani and Doordarshan to Prasar Bharati on certain conditions.
